The *Friend of ESP Award* may be bestowed upon any person or organization whose leadership, acts, dedication, commitment, and support on the statewide level have proven that person or organization to be a true friend of and advocate for ESP and their contributions to public education and students. An individual recipient need not be an American citizen, but he or she should reflect the philosophy and principles of NJEA. Individual nominees may be public or private citizens, and selection of finalists will be made regardless of age, sex, race, color, or creed. If an individual nominee is eligible for active NJEA membership, such membership is a requirement.

### Application Process

Each nomination will be checked to ensure that it meets eligibility requirements. The NJEA ESP Committee will serve as the selection committee. The selection committee will not know any applicant's personal identity, local or county, and will review applicants according to the criteria and purpose listed. The committee will forward the selected applications and recommendation to the NJEA president and/or Executive Committee.

Any member of NJEA or a county/local association may nominate an individual or group by writing a nomination statement to the ESP Committee. The nomination statement should address the following questions:

1. How has the individual or group contributed towards the betterment of Educational Support Professionals?
2. How does the individual or group reflect the philosophy and principles of NJEA?
3. How has the individual or group demonstrated creativity and innovation in making a difference for Educational Support Professionals?

Please provide letters of endorsement — *Limit 2 letters* — Letters should note how long the writer has known the individual or group and in what capacity the writer is able to comment on the individual or groups' professional, and/or community work, as well as any honors or achievements the individual or group may have received and a short resume or bio.
