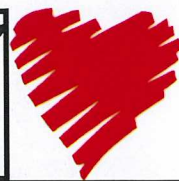

### **Self-Nominating Procedure**

**Nominations for NEA Representative Assembly state delegate positions shall be made only through self-nomination on forms prescribed by the NJEA Elections Committee or online via procedures described on the Members Only section of [njea.org](http://njea.org). Each candidate must file a form before 5 pm on February 27, 2012 to the NJEA Headquarters. Forms can be faxed or mailed, but it is the candidate’s responsibility to verify receipt of the form at NJEA. See the January 2012 edition of the *NJEA Review* for complete rules and procedures.**
