# PD WORKSHOP DESCRIPTIONS

## 2019-2020

### **#2020-1 Understanding ACEs**

#### **Part 1**

Participants will be introduced to the neuroscience of how trauma impacts the brain, the Adverse Childhood Experiences Study and how to build a Self-Healing Community. This workshop encourages a shift in the way we think about our students' behavior and overall mental and physical health. This workshop is a prerequisite for **Becoming a Self-Healing Community**:

#### **Part 2 - Building a Self-Healing Community**

*This session can only be taken if participants have attended ACEs Part 1: Understanding Adverse Childhood Experiences.*

Participants consider the overall health and well-being of their school community and begin to develop an action plan to intervene and shift their school community into a self-healing community.

### **#2020-2 Praising the Process - The Powers and Pitfalls of Growth Mindset**

Throughout this session, participants will explore growth and fixed mindset, strategies for successful implementation in the classroom, and cautions to avoid misinterpretation and misguided application of Carol Dweck's work.

### **#2020-3 Google Open Forum**

Google Open Forum is an opportunity for participants to ask and answer all of their burning questions about using Google tools in the classroom. This session is designed so NJEA Google experts can walk participants through the steps to answer questions as well as facilitate conversations between members. Google Open Forum is a unique experience every time. Bring your own device.

### **#2020-4 Intro to Restorative Justice in School**

This is an introduction to the practices of Restorative Justice in Education. Restorative justice isn't just a technique or tactic. It's a paradigm shift in the way schools think about discipline that asks educators to fundamentally challenge their perceptions of students who violate school policies.

### **#2020-5 Succeeding with Challenging Students for ESP**

This workshop provides participants with specifics in succeeding with students who are continually disruptive, persistently defiant, demanding of attention, or unmotivated.
